



# GENERAL AGREEMENT

Non-Profit-Organization International Karate Daigaku (IKD) represented by Shuseki Shihan Frank Woon-A-Tai from one side and Non-Profit-Organization International Karate Daigaku Association Australia (IKD-Australia) represented by president and chairman Hamid Mostofizadeh from other side hereinafter deemed as "Licensee" and "Licensor" has arranged following agreement :

## 1. SUBJECT OF AGREEMENT

- 1.1 For development and wide spreading of Karate-do of IKD version both parties have agreed to join efforts in implementation of events which are subjected in statutes.
- 1.2 IKD Australia will be deemed as official representative of IKD in Australia until exited by one of the parties.
- 1.3 IKD will guarantee that IKD Australia will solely represent IKD in Australia.
- 1.4 IKD gives the right to IKD Australia to use name and symbols of IKD. The IKD prohibits other organisations to use the IKD name and logo without written permission from the IKD.



## 2. OBLIGATIONS


2.1 Both parties have agreed to support each other in dissémination of information in international and local sport organizations and media.

## 3. RESPONSIBILITIES

- 3.1 This Agreement contains the full and complete understanding between the parties and supersedes all prior agreements and understandings pertaining hereto and cannot be modified except by a writing signed by each party.
- 3.2. In the event the Licensor ceases to be a member in good standing of the International Karate Daigaku Inc., for any reason, Licensor, shall immediately discontinue the use of the IKD Crest and Marks as well as the IKD's name.
- 3.3 Licensee warrants that it is or represents the owner of all right, title and interest in and to the IKD Crest, Marks and Name, including, if existing, its copyright thereof, that it has the right to enter into this agreement and to grant the rights contained herein, and that the consent of no other person, firm, corporation or labor organisation is required in order to enable Licensee to use the IKD Crest, Marks and Name in the manner described above, and that Licensor's use thereof in that manner will not violate the rights of any third parties.
- 3.4 Licensor shall indemnify and hold Licensee and its successors, assigns, agents, representatives, associates, affiliates, licensees, parent and subsidiary corporations, and each and all of them harmless of and from any and all loss, costs, damage, liability and expenses, including reasonable attorneys' fees, arising out of any breach of Licensor's warranties and representations, hereunder.
